In this case, the Company relies on the best execution policy of such third parties, upon review and monitoring. In this context, the Company in accordance with the Delegated Regulation (EU) 2017/565 of the Commission (art. 65 par. 6), summarizes and publishes on an annual basis for each category of financial instruments, the top five investment companies - in terms of trading volume - to which it transmitted or executed its clients' orders, as well as data related to the quality of execution. The published information refers to Retail and Professional clients and follows the format set out in Annex II of the Delegated Regulation (EU) 2017/576 of the Commission.
